## INDIVIDUAL MOBILITY

This page is meant for foreign students outside the European Union (if not, please visit the registration page).

You will need to prove that you have a good level in French.

### You reside in France

**You wish to enrol in the first year of a bachelor's degree or in the first Year of Health Studies: 2 courses are possible**

- » LAS : a license with an option "health access"
- » PASS : A specific health access course with an option from another discipline

A "Demande d'Admission Préalable" (DAP : Request for Preliminary Admission) is mandatory for foreigners with a foreign high school diploma: download the green Demande d'Admission Préalable form on the website of the Ministry of Higher Education from November 1st 2020. Changes are being made in the application review procedure and timetable compared to previous years.

Your application file is examined at the same time by the 3 universities you applied for. Applications must be returned simultaneously to the 3 selected universities, accompanied by supporting documents, no later than January 17th 2021 (as evidenced by the date as postmarked).

### **You wish to register in BUT**

Apply via the Parcoursup website between January and March.

### **You wish to register for a professional license**

Download the paper application form on the training form of the professional licence in which you wish to register.

### **You wish to register in the 2nd or 3rd year of the bachelor's degree or in the 1st or 2nd year of the Master's degree**

Fill out an application form on the UVSQ website using the e-candidature application (open in March).

For the Paris Saclay Master's Degrees, the application is online.

## **You live abroad**

### **You wish to enrol in the 1st year of the bachelor's degree or in the first Year of Health Studies: 2 courses are possible**

- » LAS : a license with an option "health access"
- » PASS : A specific health access course with an option from another discipline
  
- » Your country is a country with a "Studies in France" procedure: fill in an application form on the Etudes en France website (available from November 1th 2020)
- » Your country is not a country with a "Studies in France" procedure: obtain or download a white Demande d'Admission Préalable form from the Service de Coopération et d'Action Culturelle of the French Embassy in your country.

Changes are being made in the application review procedure and timetable compared to previous years. Your application file is examined at the same time by the 3 universities you have requested.

### **You wish to register in BUT:**

- » Your country is a country with a "Studies in France" procedure: fill in an application form on the Etudes en France website from November 1st 2020.
- » Your country is not a country with a "Studies in France" procedure: apply via the Parcoursup website between January and March.

### **You wish to register for a professional license:**

Foreign students not yet residing in France cannot apply for this type of licence.

### **You wish to enrol in the 2nd, 3rd year of the bachelor's degree or the 1st, 2nd year of the Master's degree:**

#### **100% UVSQ training:**

- » Your country is a country with a "Studies in France" procedure: fill in an application form, on the website of your Campus France space, from November 1th 2020.
- » Your country is not a country with a "Studies in France" procedure: fill out an application form on the UVSQ website using the e-candidature application (open in March).

### **Master's degree from Paris-Saclay University:**

Step 1: Apply on the Paris-Saclay application platform.

Step 2: Once you have been admitted:

- » Your country is a country with a "Studies in France" procedure: prepare your visa application file on Studies in France by choosing the "I am accepted" option and downloading your admission notice from the University of Paris-Saclay.
- » Your country is not a country with a "Study in France" procedure: apply for your visa at the consular services closest to your home.

## **Registration**

If your application is accepted, you will receive a confirmation letter. It will contain the information necessary for your administrative registration.

In order to prepare your arrival and your academic year as well as possible, we strongly advise you:

- » to find out about the various **administrative procedures** to be carried out (visa, opening a bank account, health insurance, transport, etc.): the application provided by the Paris-Saclay University website offers you a roadmap. You can also consult the pages VisaFormalities, Financing your studies in France and Accommodation on our site.
- » to find out more about the French university system
- » to find out more about **UVSQ**, its campuses, its services (libraries, university restaurants...), how it works (timetables, calendars...), the activities on offer... You can take part in the French courses given by the CEREL (for a fee). The University Paris-Saclay offers a sponsorship system (accompaniment by another student) to which you can register.
- » to find out more about the **Île-de-France region**: cost of living, transport networks, administrative structures, cultural structures, sports structures...
